What if you already have a will or trust?

You can amend your will or trust and make a gift without rewriting the entire document. Your attorney can prepare a simple document, called a codicil, which adds a new bequest to the Sons of the Revolution while reaffirming the other terms of your will. Similarly, an attorney can prepare an amendment to a revocable trust to add The Sons of the Revolution as a beneficiary.

A bequest is one of the simplest ways to support 1) The Sons of the Revolution in the State of California, and 2) its American Heritage Library and Museum. Your gift will ensure that we can continue our critical work to protect the heritage that exists in our Library.

How it works

Is a bequest deductible?

Yes. The Sons of the Revolution in the State of California is a 501(c)(3) charity, and as such your bequest is fully deductible for federal estate tax purposes. There is no limit on the deduction your estate can claim. In addition, the gift is usually exempt from state inheritance taxes.

What is the difference between a will and a trust?

- A will is your instruction manual to survivors about how you want your property distributed.
 It is a revocable, private document that only takes affect after your death.
- A revocable trust is an entity that holds assets during your lifetime, then transfers ownership of them — or benefit from them — upon your death.

There is no difference between a will and a trust in terms of how they make charitable transfers. In some states the probate and distribution process is simpler with a revocable trust. Your advisor can guide you in choosing which vehicle will work best for you.
